## Pilot Examiner Log Book Filling Instruction:

Examiner shall attend mandatory Examiner training courses / briefings and those shall be entered into this Log Book.

It is responsibility of each Examiner to use this Log Book and to record it on daily basis.

For Proficiency check entry – PC and for Skill test entry – ST, for Assessment of Competence entry - AoC.

For each entry the Examiner must have a copy of completed Proficiency check or Skill test form or for Assessment of Competence.

Each entry has to be signed by Log Book owner. Fake entries are considered as major violation.

Regular inspections of entries are carried out by CCAA Inspectors. This Log Book and copies of completed Proficiency checks or Skill tests forms shall be available to CCAA's Inspectors request at any time.

All entries have to be legible and permanent ink (pen) shall be used.

Log Book shall be kept as whole, no missing pages are allowed. If Log Book is damaged or lost, immediately contact Training and Licensing Department.

Log Book shall be used only by one Examiner in validity period of Examiner's certificate. During revalidation process an original shall be submitted to CCAA.

"ROLE": Examiner shall put only one specific role relevant to ST/PC performed (such as: FE(A) or SFE(A) or TRE(A), etc.). If the role is CCAA inspector or Senior Examiner, put the "SEN".

 $_{\rm A}$  / H / B / S / FSTD": If A / H / B / S fill the registration of aircraft. If FSTD, fill the qualification number of FSTD (code).
